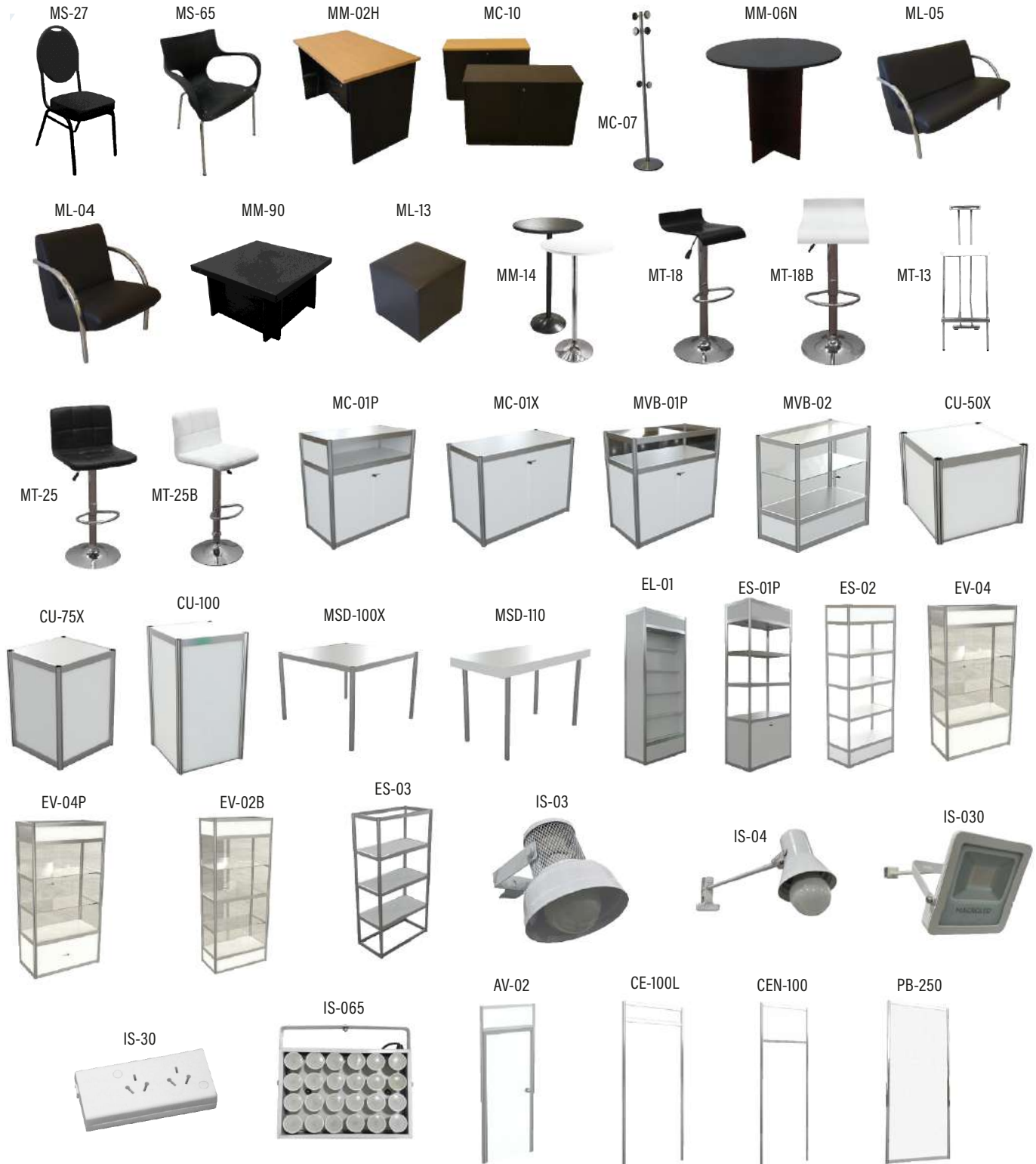

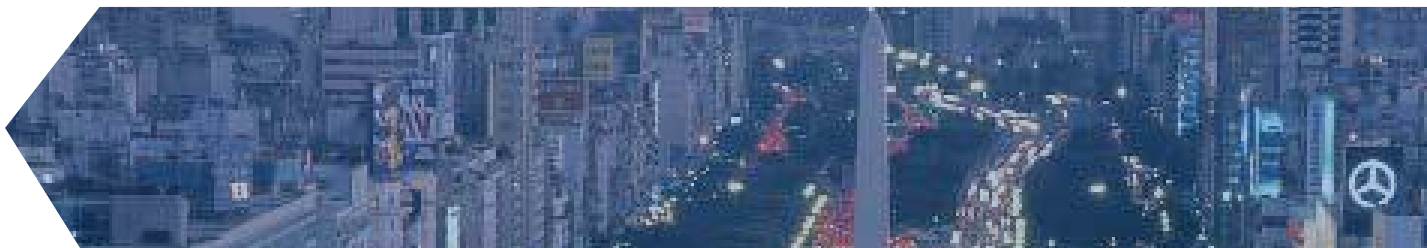

SHIPPING SAMPLES: Argentine customs clearance procedures for incoming and outgoing freight shipments for trade shows within Argentina are very detailed and time-consuming, and the authorities are rigid and exceptionally rigorous in the enforcement of prevailing Argentine customs regulations. We strongly suggest NOT to hand-carry any samples and to contact your freight forwarder in order to make a temporary

EXPRESS SHIPPING INSTRUCTIONS

CUSTOMS REGULATIONS

The rules and regulations for importing goods into Argentina are very strict. We strongly suggest that you contact us before shipping any goods. Deadline dates and most important Customs Regulations are listed below. Copy of our International Shipping Instructions & Tariff is available upon request.

DEADLINE DATES

Sea Freight Shipments to Buenos Aires Port	August 28th, 2026
Air Freight Shipments to Ezeiza Airport	September 5th, 2026

SHIPPING & PACKING YOUR EXHIBITS

TEMPORARY AND DEFINITIVE CARGO MUST BE SHIPPED, INVOICED AND PACKED SEPARATELY.

Argentina has specific entry regulations, which must be followed, or your shipment will be denied entry. Separate Invoices / Packing Lists and Airway bills / Bills of Lading are required for PERMANENT and TEMPORARY entries.

SHIPMENT DOCS & DETAILS / DEADLINES

For all shipments, 30 days before shipment date Do not ship before receiving our OK or "green light" There are some previous Customs procedures required to be approved to secure the Customs release.

TEMPORARY ENTRY

The venue in Buenos Aires is not a customs bonded area and temporary imports will require a Guarantee in order to avoid payment of duty. We will provide this guarantee upon application.

PERMANENT ENTRY

CUSTOMS DUTIES & TAXES

All trade advertising, giveaways, promotional literature and expendable items must be imported only as PERMANENT and are subject to heavy import duties and taxes.

This amount will be administered and assigned by the Customs Administration and will be applicable only for consumable goods.

PLEASE BE CAREFUL WHILE SHIPPING YOUR GIVEAWAYS:

- **Bags:** The only bags that can be imported are the ones that are made from plastic and paper / cardboard. Please do not ship textile bags.
- **Food and beverages:** Sanitary procedures are required. If you intend to send food stuff please request special shipping instructions.
- **Toys:** Please note that we are not able to import toys because they require special licenses that usually take between 3 and 6 months to get them.

- Brochures and printed material: Due to new regulations in our country we are only able to import brochures that promote products or services from abroad. So, in order to avoid problems at customs please send us a copy of your brochure in order to check it and give you our approval to send it.

-Batteries: The only batteries that are allowed to be imported in our countries are the ones made of lithium. Please do not ship your goods with any other kind of batteries, they can't be imported.

-Textile: Certificate of Origin legalized by the Argentine Consulate in the Country of Origin is required for textile and fabric products and for all goods in which the country of Origin is not a member of the WTA. This certificate it's required for T-Shirts, textile flags and posters, table cloths, clothes, etc. Please check with us before shipping this kind of goods.

ELECTRICAL EQUIPMENT

Permanent imports of electrical equipment require a Product Registration as per voltage, prior to entering our country. This process will take, at least, 3 months for registering product and high expenses will apply for registration purposes. Documents required will be informed upon request. We strongly recommend temporary import of this kind of products.

WOODEN CRATES & PALLETS

Be informed that, in our country, the entry of shipments packing in wooden crates and pallets, require fumigation process in origin. This procedure must be done before the shipment and the corresponding Official Certificate must be included in the documentation. If packing material is not wood, a Certificate of non-wooden Packing Material issued by the Shipper / Exporter is required to include in the documentation.

COURIER SHIPMENTS

Exhibition goods shipped through courier services have restricted regulations in Argentina. Courier companies may not deliver shipments weighing more than 50 Kg. and for a value exceeding of USD 1000 In addition there are other many restrictions based on the nature of goods We extremely don't recommend this kind of shipment. Handling and delivery charges will apply for couriers consigned to us. Do not ship goods via courier without our previous advice. Courier services can be used as international transportation but once the shipment arrives to Buenos Aires Airport customs clearance will be required. Door to door service doesn't apply.

These kind of shipments have special and strict regulations, so please read and pay attention to the attached Special Instructions.

About ARGENTINA

Argentina, with 40 million inhabitants, has a wealth of natural beauty and immensely varied scenery. It covers an area of over one million square miles and is the second largest country in South America.

In the north there are the arid Humahuaca and the tropical jungles and in the south the Antarctic ice at Tierra del Fuego.

From the marvelous rain forest in the north-east to the amazing glaciers in the southern region of the country, enjoy its outstanding sights with every new destiny.

A visit to Iguazu Falls, the largest and most extensive in the world can be combined with a horseback ride on the Pampas, whale watching in the southeast, a visit to the amazing Moreno glacier and the capital, Buenos Aires.

AIRPORT INFORMATION: Two airports serve Buenos Aires:

- **Ezeiza International Airport:** Most airlines arrive at this airport located 37 km from the city centre by highway. Bus, transfer, taxi and chauffeur-driven rented car services take approximately 40 minutes to reach the city.

- **Jorge Newbery Airport:** Visitors coming from the interior of the country or from bordering countries arrive at this airport located by the riverside, five minutes away from the city centre.

Upon arrival at the airport when looking for a taxi to take you to your hotel, it is strongly recommended that you only use taxi companies that work with leading hotels. Please contact your hotel for further advice.

PASSPORT AND VISAS: You will need a valid passport and may need a visa to visit Argentina. Ask your nearest Embassy or Consulate or visit: www.mrecic.gov.ar

VISITING BUENOS AIRES: The cultural capital of South America, Buenos Aires is located on the eastern bank of the River Plate, the widest river in the world. The city has a cosmopolitan atmosphere and, although being a modern city, it includes turn-of-the-nineteenth-century European style buildings. It has also some well preserved districts of typical colonial architecture.

Buenos Aires inhabitants are called "porteños" which makes reference to the fact that the city is a port. Buenos Aires has everything to transform your visit into a wonderful experience. Official webpage of the city: www.bue.gov.ar

CLIMATE: The climate of Buenos Aires is mild all year round. The average annual temperature is 18°C. Visitors can enjoy walking around the city in any season. On a sunny day in spring, mornings are mild; the temperature rises at midday and drops softly at night. The average temperature for September is between 15° and 20° C (59° - 68° F).

LANGUAGE: The official language is Spanish and the local people also easily understand Italian and Portuguese. However, most people involved in tourist activities speak English.

TIME DIFFERENCE: The time zone corresponds to GMT-3.

BANKS, CURRENCY, CREDIT CARDS AND VAT:

Banks open at 10 am and close at 3 pm (some banks extend their closing time to 4 pm). Cash withdrawals and other transactions may be made at ATMs, 24 hours a day.

The Argentine currency is the peso (\$). There are \$20,000, \$10,000, \$2,000, \$500, \$200, \$50, \$20, \$10 and coins \$1, \$2, \$5 and \$10.

The U.S. dollar (USD) is the most common foreign currency. US dollars or Euros can be bought or sold at banks and currency exchange offices (casas de cambio), where you must present your passport. Most of the shops accept mayor credit cards (Visa, AMEX, Mastercard) and dollars but it is sometimes more convenient to pay by cash with pesos exchanged in your hotel.

The VAT rate in Argentina is 21%. As a foreign visitor, you have the right to a refund of the value-added tax included in the price of the articles you take to your country. At the airport you may obtain a VAT reimbursement corresponding to any purchases made within the country for an amount over \$ 70 (per invoice) and in shops operating with the Global Refund system.

ELECTRICAL POWER: Electrical power in Argentina is 220 volt, 50-cycle alternating current. Power outlets have two cylindrical holes or two flat holes with ground connection. It is convenient to bring an adaptor for these outlets to use your electrical devices without problems.

SECURITY: Buenos Aires has the reputation of being a safe city, but as in any other big city in the world, tourists should take sensible precautions.

MAKING PHONES CALLS: For international calls, dial 00 +country code + area code + local number.

The country code for Argentina is 54, and the area code for Buenos Aires is 11. For example, to call to 4333-6666 from outside the country, you should dial +54 11 4333 6666.

OPENING HOURS: Shops are open from Monday through Fridays from 9 am to 8 pm, and Saturdays from 9 am to 1 pm; however, shops in main locations are also open on Saturday afternoons. In malls, hours usually extend until 10 pm, including Saturdays and Sundays.

Food, drinks and nightlife: Most restaurants and pubs can be found in the neighbourhoods of Palermo Soho, Palermo Hollywood, Puerto Madero, Las Cañitas and San Telmo. Several Buenos Aires restaurants have made it to the list of Latin America's best restaurants.



TANGO

Buenos Aires is the birthplace and the world capital of tango, a rhythm that was created by the banks of the Río de la Plata, at the end of the 19th century, as a fusion of European and African music. The tango is manifested in the lyrics - many of the words used in the tango come from lunfardo (porteño's slang); in the music - the bandoneón provided the music from the Río de la Plata with that melancholic and somewhat sullen sound that characterizes tango today; and in the dance - tango classes last between one and two hours. It is ideal to take four or five lessons. From the first lesson, teachers train beginners in the mastering of the basic steps: eight

simple movements that may be learned in a few hours.

Buenos Aires is full of tango houses with live orchestras and dancers. The most important places that offer live shows usually include dinner (with options in Argentine beef or international menus).

You may also go to the milongas, places where you dance tango. Many of them organize classes - given by specialized teachers - before the dancing. For beginners and more experienced dancers, the offer includes group or individual classes. Tango, milonga or vals.
